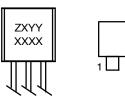

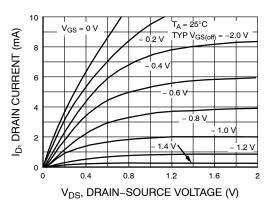


Figure 1. Common Drain-Source

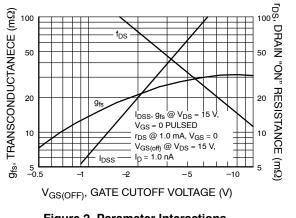


Figure 2. Parameter Interactions

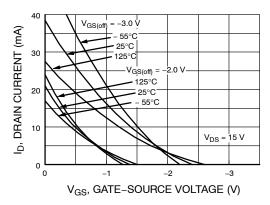


Figure 3. Transfer Characteristics

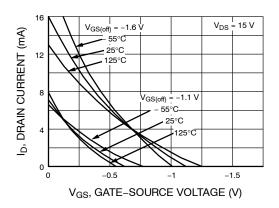


Figure 4. Transfer Characteristics

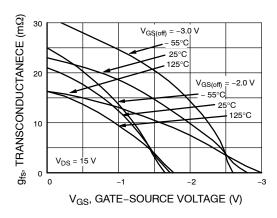


Figure 5. Transfer Characteristics

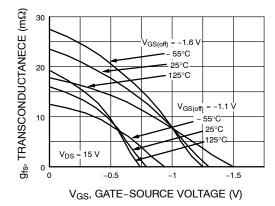


Figure 6. Transfer Characteristics

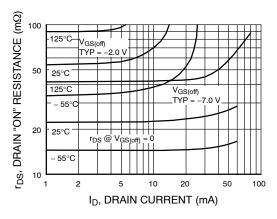


Figure 7. On Resistance vs. Drain Current

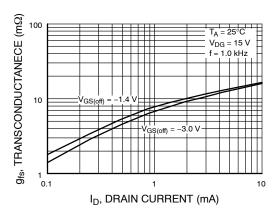


Figure 9. Transconductance vs. Drain Current

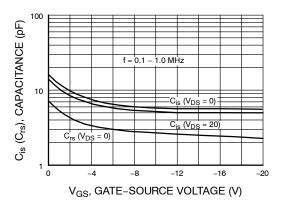


Figure 11. Capacitance vs. Voltage

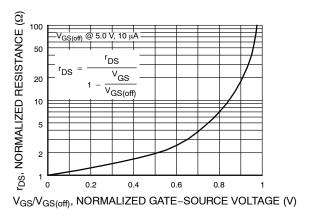


Figure 8. Normalized Drain Resistance vs. Bias Voltage

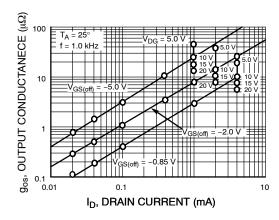


Figure 10. Output Conductance vs. Drain Current

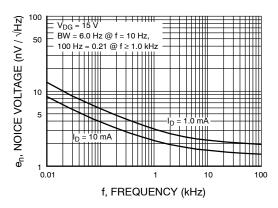


Figure 12. Noise Voltage vs. Frequency

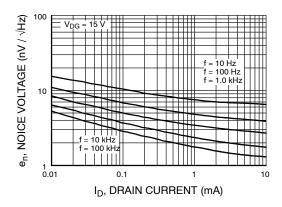


Figure 13. Noise Voltage vs. Current

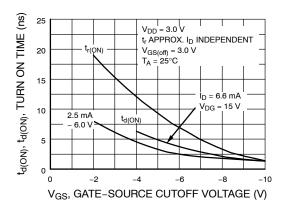


Figure 15. Switching Turn-On Time vs. Gate-Source Voltage

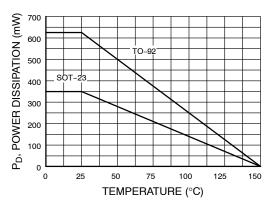


Figure 14. Power Dissipation vs.
Ambient Temperature

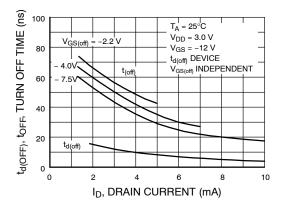


Figure 16. Switching Turn-Off Time vs.

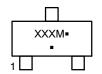
